

Agreements and Responsibilities of Applicant:

1. I agree and understand that if the cat(s) is not already spayed or neutered it is my mandatory responsibility to do so by Not applicable
2. I agree and understand that I must provide veterinarian documentation, proving spay/neuter, to be hand delivered to Jamie's Legacy at 3647 W 200 N, Huntington, IN or by email to jamies.legacy@yahoo.com within 48 hours of operation.
3. I agree and understand that if proper proof of spay/neuter is not received by Not applicable without prior approval for extension, that I will relinquish the cat(s) into the direct care of Jamie's Legacy without delay or interference
4. I agree and understand that it is my responsibility to have this cat(s) examined by my own veterinarian at my own expense within 30 days of adoption.
5. I am aware that a feline may live up to 15 years or more and can cost hundreds of dollars per year for basic nutrition and medical care. I am willing to accept this responsibility.
6. I agree that if at any time I can no longer care for my cat(s) I may not sell, trade, euthanize, or give it away without written permission from Jamie's Legacy (initial)
7. I understand that any cat(s) adopted from Jamie's Legacy may not be housed outside without prior disclosure and approval of Jamie's Legacy. (initial)
8. I understand that any cat(s) adopted from Jamie's Legacy may not be declawed. (initial)

We would *not knowingly* adopt out a cat(s) with undisclosed health condition(s). It is not always known if a stray or previously owned cat has been exposed to an illness or has a genetic disorder. Under these circumstances, we *cannot guarantee* the health of each cat. We *highly recommend* you take the cat(s) to your own Veterinarian for a complete health check within 7 days of adopting. You may have Veterinary expenses for basic concerns such as ear mites or intestinal parasites (worms), etc. If your veterinarian determines a more extensive illness *within 30 days of adoption*, Jamie's Legacy *will not be liable* for any costs incurred by you *without prior written approval from us*. If a more serious illness is diagnosed within the 30 day period, you may return the cat(s) to us with a full refund of your adoption fee. If you choose to keep the cat(s), after the 30 day period *any and all* medical expenses *will be solely your responsibility*.

The information I have given in this application is correct and truthful. I understand that Jamie's Legacy reserves the right to approve or reject applications at their discretion. Applications are approved pending confirmation of all information given and the opinion of Jamie's Legacy as to what is in the best interest of the cat(s). No cat will be released by Jamie's Legacy prior to that approval.

I agree, that if approved, the right of Jamie's Legacy to perform one home visit after adoption, at their discretion and without prior notice, any day of the week between the hours of 9:00 am & 7:00 pm, within 6 months of adoption, and that at such time, I will allow them access to my home and the cat(s).

I understand, that if approved and within 6 months any information given is found to be false, or the home conditions are found to be unsafe, unsanitary, false, or in direct conflict with this agreement, that Jamie's Legacy reserves the right to remove any cat(s) from my possession.

I release my veterinarian to provide the needed information concerning medical care of current/previous pets in my household/name.

I give Jamie's Legacy the right to check with any animal shelter to verify if any one of my household has relinquished any animals in the past.
